Ordinance No. 2009-23

**AN ORDINANCE AMENDING CHAPTER 102 “FEES” OF THE REVISED
GENERAL CODE OF THE TOWNSHIP OF MANALAPAN**

I

BE IT ORDAINED by the Township Committee of the Township of Manalapan, County of Monmouth, and State of New Jersey that Chapter 102 “Fees” be and is hereby amended and supplemented and renumbered as follows:

§ ARTICLE I Public Documents and Services

§ 102-1. Inspection of public records.

Public records of the Township shall be open for inspection by members of the public as provided by law (N.J.S.A. 47:1A-1). Such inspection shall be made only at reasonable times during business hours and without interference to the conduct of the affairs of the office or other place where such records are kept or maintained.

§ 102-2. Fees for copies.

The following fees shall be charged for copies of public documents:

- A. Fee for certified copy of a vital statistics record: [~~\$8~~] \$15 each
- B. Fee for certified corrected copy of a vital statistics record: [~~\$8~~] \$15 each
- C. through O. No Change.

§ 102-3 through § 102-5. No Change.

§ 102-6. Training Classes held by the Township of Manalapan.

\$100.00 per attendee

II
SEVERABILITY

If any section, subsection, clause or phrase of this Ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this Ordinance.

III
REPEAL

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

IV
EFFECTIVE DATE

This Ordinance shall take effect upon due publication according to law.
