Ordinance No. 2011-02

AN ORDINANCE AMENDING CHAPTER 84 “COMMUTER PARKING”, ARTICLE I “COMMUTER PARKING AREAS – PAY PER YEAR”, SECTION 84-4 “ISSUANCE OF PERMITS” OF THE REVISED GENERAL CODES OF THE TOWNSHIP OF MANALAPAN

BE IT ORDAINED by the Township Committee of the Township of Manalapan, County of Monmouth, and State of New Jersey that Chapter 84 “Commuter Parking”, Article I “Commuter Parking Areas – Pay Per Year”, Section 84-4 “Issuance of Permits” be and is hereby amended as follows: (Text added is underlined, deleted text is [bracketed])

I

ARTICLE I, Commuter Parking Areas – Pay Per Year

§ 84-01 through 84-03, No change

§ 84-04. Issuance of Permits

A. through C. No change

D. Application and renewals thereon shall be for one year or any part thereof, terminating on March 31, and the annual fee for same shall be [~~\$150.~~] \$201.00. In the event that a tag is issued during the annual period from April 1, through March 31, then the charge for same shall be at [~~\$12.50~~] \$16.75 for each month remaining during the aforesaid period. No refunds shall be made.

If any section, subsection, clause or phrase of this Ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this Ordinance.

REPEAL

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

This Ordinance shall take effect upon due publication according to law.
