ORDINANCE NO. 2012-16

AN ORDINANCE OF THE TOWNSHIP OF MANALAPAN IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 163 “PARKS AND RECREATION AREAS”; ARTICLE III FEES, SECTION 12 ‘MAXIMUM FEES’ TO SET FEE RANGES FOR FEES ASSOCIATED WITH MANALAPAN TOWNSHIP PARKS AND RECREATION EVENTS, PROGRAMS AND FACILITIES

BE IT ORDAINED by the Township Committee of the Township of Manalapan, County of Monmouth, State of New Jersey that Chapter 163 “Parks and Recreation Areas”; Article III (Fees), Section 12 (Maximum Fees) is hereby amended and supplemented as follows: (new text is underlined, deleted text is [bracketed])

Section I

ARTICLE III, Fees

[§ 163-12. Maximum Fees.]

[The Township Committee shall establish by resolution the registration fees for individuals participating in various programs, the fees for the sponsorship of various programs and activities, and the concession fees for the use of various facilities or the sale of goods and products in Township facilities.]

§ 163-12. Minimum-Maximum Fee Ranges.

The annual rate of fees to be paid by persons for the following Parks and Recreation Events, Programs and Facilities in the Township of Manalapan shall be fixed yearly by resolution. Said fees shall be consistent with the amounts set forth herein.

Section IV

EFFECTIVE DATE

This Ordinance shall take effect immediately upon final passage and publication according to law.
