

TOWNSHIP OF MANALAPAN

ORDINANCE NO. 2012-17

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 185 “SEWERS AND SEWAGE DISPOSAL”, ARTICLE III (DISCHARGES INTO PUBLIC SANITARY SEWERS) SECTION 16 GREASE TRAPS AND SECTION 17 VIOLATIONS AND PENALTIES OF THE CODE OF THE TOWNSHIP OF MANALAPAN, COUNTY OF MONMOUTH AND STATE OF NEW JERSEY

BE IT ORDAINED by the Township Committee of the Township of Manalapan, County of Monmouth, and State of New Jersey that Chapter 185 “Sewers and Sewage Disposal”, Article III (Discharges into Public Sanitary Sewers) is hereby amended and supplemented as follows: (new text is underlined, deleted text is [bracketed])

Section 1

ARTICLE III, Discharges into Public Sanitary Sewers

§ 185-16. Grease traps.

A. through D. NO CHANGE.

E. This Article shall permit Western Monmouth Utilities Authority to recover all costs associated with their services in clearing a blockage due to an oil and grease discharge into a Western Monmouth Utilities Authority sewer line by a local restaurant and food establishment.

§ 185-17. Violations and Penalties.

Any person violating this article shall be subject to a fine not exceeding \$1,000 or imprisonment for 90 days, or both, in the discretion of the Judge of the Municipal Court of the Township of Manalapan. Every day shall be considered a separate and distinct offense.

Section II

SEVERABILITY

If any section, subsection, clause or phrase of this Ordinance Is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this Ordinance.

Section III

REPEAL

All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section IV

EFFECTIVE DATE

This Ordinance shall take effect immediately upon final passage and publication according to law.
