**Ordinance No. 2009-03**

**AN ORDINANCE AMENDING CHAPTER 226 “VEHICLES AND TRAFFIC”, ARTICLE XVI  
“COMMUTER PARKING AREAS” OF THE REVISED GENERAL CODES OF  
THE TOWNSHIP OF MANALAPAN**

**BE IT ORDAINED** by the Township Committee of the Township of Manalapan, County of Monmouth, and State of New Jersey that Chapter 226 “Vehicles and Traffic”, Article XVI “Commuter Parking” be and is hereby amended as follows: (Text added is underlined, deleted text is [bracketed])

**I**

**Section 226-54**

***A through C. No change***

***D. Application and renewals thereon shall be for one year or any part thereof, terminating on March 31, and the annual fee for same shall be [~~\$120.~~] \$150. In the event that a tag is issued during the annual period from April 1, through March 31, then the charge for same shall be at [~~\$10.00~~] \$12.50 for each month remaining during the aforesaid period. No refunds shall be made.***

**II**

**SEVERABILITY**

If any section, subsection, clause or phrase of this Ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this Ordinance.

**REPEAL**

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

**EFFECTIVE DATE**

This Ordinance shall take effect upon due publication according to law.
