**AN ORDINANCE AMENDING AND SUPPLEMENTING THE MUNICIPAL
CODE OF THE TOWNSHIP OF MANALAPAN ARTICLE II
COMMUTER PARKING AREAS (DAILY PARKING)
CHAPTER 84 COMMUTER PARKING
SECTION 10: RESIDENCY PERMIT REQUIREMENT**

WHEREAS, Municipalities are empowered to make, amend, repeal and enforce ordinances pursuant to N.J.S.A. 40:48-1 et. seq.; and

WHEREAS, it is the intension of the Township Committee to amend the Municipal Code of the Township of Manalapan Article II, Chapter 84 Section 10: Residency Permit Requirement; and

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Manalapan, County of Monmouth, State of New Jersey as follows: Text added is underlined, deleted text is [bracketed]

Section 84 – 10: Residency Permit Requirement.

- A. Proof of residency shall be established in the same manner as for yearly permits for residents of Manalapan Township; or a municipal tax bill for residential property in the Township of Manalapan shall be acceptable proof of residency. and shall be valid for a period of two years expiring on September 30. Permits issued during the months of June through September shall not be counted as a year.

All ordinances or provisions thereof inconsistent with this ordinance are hereby repealed.

This ordinance shall take effect upon adoption and publication according to law.
