Baseball/Softball field, Soccer/Football fields use of lights, add \$20.00/hr. resident/\$40.00/hr. non-resident. Basketball Court, Street Hockey use of lights add \$15.00/hr. resident/\$30.00/hr. non-resident. Recreation sponsored program light expenses will be assessed against program collected revenue. Manalapan High School, Manalapan-Englishtown Schools will be assessed fees under Class A - no light fees will be charged.

Organizations, in addition to the above rates, shall pay the salaries of custodians, parks and recreation employees, police, etc., that may be required (see #8, RENTAL RULES AND REGULATIONS)

CLASS A Any Manalapan Township sponsored activity (individual fees collected)

CLASS B Any charitable or non-profit community organization offering to present a lecture or program, instructive and beneficial to the public, including individuals/groups wishing to use for private party. Facility usage by Manalapan Township organizations shall be \$0 per person, provided total registration of said organization is 85% Manalapan residents and said organization is acting as host. Otherwise, there shall be a \$3.00 per person (p.p.) fee for non-residents. In the event the calculated fee exceeds the rate in Class C, the Class C rate shall be applied.

CLASS C Any non-Manalapan organization, group or person from which an individual or individuals may profit, or an individual team, any organization not included in Class A or B. Excludes individuals and groups for private parties.

TENNIS COURTS FEES AND REGULATIONS

1. Courts will be on first come first served basis when courts are not in use by Parks and Recreation sponsored programs or other reservations.
2. No private instruction will be permitted except for Parks and Recreation sponsored instruction.
3. Courts can be used for one hour only, on the hour, with the exception of doubles which can be reserved for two consecutive hours, on the hour. If only two members of the foursome remain, the court time reverts to one hour. This regulation exists only when courts are full and public is waiting to utilize facility.
4. Reservation fees:
Court use is free unless reserved in advance. Fee for reservation:
\$4.00 resident per person per hour
\$8.00 non-resident per person per hour
5. Rainout fees will be credited to the next time the individual reserves tennis space.

ALL PURPOSE, BASEBALL/SOFTBALL FIELDS

1. Usage of All Purpose, Baseball/Softball fields will be on a priority basis as outline in Policy #1119.
2. All Purpose fields will be rested as determined for maintenance purposes.
3. No organized team practices will be permitted on the All Purpose, Baseball/Softball, fields. The intent of this policy is to preserve fields by eliminating uses by teams functioning purely in a practice, instructional type setting. It is not the intent of this policy to interrupt Parks and Recreation department scheduled uses, local school district uses or general public free play.
4. Organizations shall be those groups that have specific responsibilities and are united for a stated purpose, have a Board of Directors and have a minimum of 4 teams.
